<u>Residents' Requests and Comments</u>: All comments read into the record by Clerk of Council. <u>Submitted by Ward 2 resident Belinda Hill:</u>

"I spoke with Andrea Mitchell on several occasions and spoke with Elona White and left a message regarding excessive speeding on Meadowlark Lane. My friend had his car demolished by someone hitting it while it was parked in front of my home. My daughter and I both had our sideview mirrors damaged by cars exceeding the speed limit and fleeing the scene. I also have an autistic grandson and fear for his life due to the speeding and traffic. Drivers use this street as a shortcut to Cleveland and other outlying areas to avoid traffic and lights. I have lived here since April, 1992. I have seen the steady flow of traffic increase over the years. I saw on Channel 5 noon news that Akron is using a Speed Table on Edgewood in their city. I believe it was in the Akron Beacon Journal also. What must we do to give that a try on Meadowlark Lane? Andrea Mitchell suggested I get some neighbors together and on the Zoom council meeting but I will try but this is short notice. How do I get on the conference call, if I want to get on? I hate to see

someone get killed or seriously injured before any action is taken before anything is done regarding the speeding on Meadowlark Lane. Thanking you in advance"

Announcements from Directors

Finance Department – Director Karen Howse reported that they are on track with their timeline for the new financial software. She stated they will go live earlier than anticipated in October. Director Howse stated she will provide a more specific date and information on training when she is aware. She reported that she received notice that the City has received additional COVID-19 relief funding from the County in the amount of \$251,000. She shared that soon the Department will have to prepare an audit of how they have used the money received thus far. She reported that they are moving along well with converting to Regional Income Tax

Agency and CCA has been wonderful with cooperating and providing the information to transfer over.

Fire Department – Chief Herb Waugh wished everyone a good evening. He thanked Council and Mayor Sellers for the passing of legislation for the two firefighters. He commented that they will be excellent additions to the Fire Department. He announced there is a Rescue Squad being built and in its final phase, ready for delivery by the end of the month. He encouraged everyone to be safe and maintain social distancing from others.

Mayor Sellers informed everyone that it will be Economic Development Director Jerome DuVal's last Council Meeting as he has accepted another position.

Economic Development – Jerome DuVal thanked Mayor Sellers for the opportunity to serve this great City and all the teachable moments he has had in the past five years under his leadership, specifically how to become a better negotiator and approach deals. He thanked his Direct Supervisors, Chief of Staff Kelli Wilson and Police Chief Wes Haynes for the work they have been able to do to move the City forward. Director DuVal thanked City Council for their support, guidance and putting the City first. He commented that this is a small City doing big things and the work they have done will further this City decades to come. He wished the City continued success. Councilwoman Andrea Mitchell stated it would make sense that it is a chilly night because her heart is a little chilled. She stated one of the most coordinated people she has ever worked with is leaving. She commented on the conversations she has had with him and his advocating for the City at National League of Cities. She thanked him for everything. Councilwoman Mitchell thanked Chief Waugh on the brand new hires and Mr. White for his service on Civil Service

Commission. She addressed Ms. Hill on Meadowlark and how hazardous it is when people are driving on the hill. She commented she has heard from several residents about this issue and is appreciative that Police Chief Haynes plans to address it.

Councilman Walter Stewart congratulated Jerome, stating he has been a great inspiration and been a vital part in moving this City forward with his vision for this City. He emphasized the importance of voting and that we are getting close to November. He stated this is probably the most important election coming up since he has been voting. He commented he was disappointed on Labor Day weekend because he saw too many large gatherings without people wearing masks and social distancing.

Councilwoman Elona White wished everyone a good evening. She wished Director DuVal the best of luck and that he has been "a special force" in the City of Warrensville Heights and she hopes he does well in New York.

He shared he met Director DuVal years ago in another forum and at a time when he needed a new voice to come in and lead Economic Development. He explained that Jerome DuVal came from a very big organization and came to our small City with the understanding of what we are trying to do. He stated Director DuVal has done an excellent job and worked extremely hard to make sure his experience could be utilized in a number of fashions. He thanked him for organizing the Food Bank and all of his other efforts. He commented he has been a great advocate for the entire organization and we are all sad to see him go. He shared that Jerome has a great family and would be at every City event that we had. He commented we will miss him and his family and there will be tough shoes to fill.
