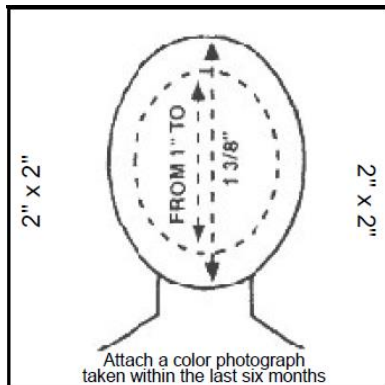

5. Student must complete the essay and provide one Letter of Recommendation (see sections V & VII).
6. Student must currently reside within the Northern District of Ohio, served by the FBI Cleveland Office.
7. Student must attend all four (4) days of the FAIT Academy and be responsible for their transportation to and from the FBI Cleveland Field Office (FAIT Academy hours are 8:00 a.m. to 4:00 p.m).
