<u>Departmental Reports</u>: Mayor Sellers stated that Council should have a copy of the Departmental Reports in their possession. He stated that if they have any questions to please reach out to the individual Director. He stated that if they have additional questions, they can contact the Office of the Mayor as well for further discussion.

Kalyn Kappelman from the Warrensville Branch of the Cuyahoga County Public Library was present at the meeting to discuss some of the upcoming programs. She stated on Sunday, March 8<sup>th</sup>, there will be an International Woman's Day presentation at 3:30p.m. with author Deborah Hill. She informed everyone that there is a Community Learning Garden and they really want to work on getting the awareness out this summer. She explained April 29-May 27<sup>th</sup> on Wednesdays there will be *Garden of the Librarian* from 7-8p.m. She stated the event entails working in the garden with the librarian and learning various skills for that. Ms. Kappelman stated that they are looking for volunteers and has programs books if anyone who would like one.

# **Residents' Requests and Comments:**

Jacqueline Boyd stated that her husband has recently gotten through a lengthy illness and hospital stay and so it has made her realize you should give flowers when people are around so they can appreciate it. She recalled a couple years ago when she was driving on Harvard Ave.

and she had stopped on the road because she started to see colors as if she was in a kaleidoscope. She shared that Fire Chief Waugh was also on the road and turned around to check on her and stayed with her until an ambulance came. Ms. Boyd stated that she had never forgotten what he did so she wanted to publically thank him.

Janice Rox reported that Councilwoman Mitchell, Building Commissioner Brown and Police Chief Haynes will no longer be receiving text messages from her during holidays, vacation days and weekends because she no longer has a problem with her neighbors. She shared that they finally moved out and she would really love to do "the happy dance" and commented she is blessed to have them working on her behalf.

Herbert Addison Burns reported he is the president of Friends of the Library and he stated he has a few concerns. He asked what is going to happen to Eastwood Elementary School once it closes because some of the residents are concerned about the vacancy of the building. He expressed another concern about non-residents that own real estate property in Warrensville. Mr. Burns reported that they have to register under the Fiscal Officer with Cuyahoga County per Ohio Revised Code. He shared that property owners seem to rent their property to people that do not seem to care about the maintenance of Warrensville Heights giving an example of a property owner on Hathaway Lane.

Mayor Sellers responded that Mr. Burns's question about Eastwood can be better answered by the School District but they have yet to make their public disclosure on what will be done with the property. He referred his question to the School Board. School Board President Traci Mitchell announced there will be a meeting on March 19<sup>th</sup> at 6:30p.m. at Eastwood Elementary School and residents will be notified. She reported those in attendance will be informed of what the disposition of the building might be and have an opportunity to share their recommendations on how they would like to see that area changed.

Mayor Sellers stated that the Economic Development Department Is poised and ready to talk about that property but we cannot advance it until the School Board lets us know what their intent is. He asked Building Commissioner Brown to speak to Mr. Burns's property question.

Building Commissioner Ben Brown reported that the City has a Rental Registration Program so if you are renting your property out, you do have to register it. He commented that the property that Mr. Burn's may be referring to is the property he spoke to his mother, Carole Burns about last week. He reported that the property is registered it just needs to be updated for this year. Commissioner Brown reported that there were no outstanding Building Code violations on the property. He stated if a resident observes a Building Code violation, his Department can address it. He stated if

it is not, he works closely with Police Chief Haynes about the issue.

Police Chief Haynes explained that if there is a nuisance complaint in which Officers have to continually go over to the residence, a nuisance violation will be issued that will go to the tenant and the property owner. He stated if multiple violations are accumulated, the property owner will be fined.

Mr. Burns asked how a nulsance is defined. Chief Haynes replied that it is any kind of criminal activity that can be charged in Bedford Court unless it is a domestic situation. Mr. Burns asked does there need to be evidence and Chief Haynes responded it could be a loud noise that will keep Officers visiting the property if for example, the tenants are having parties over the weekend.

Law Director Beasley explained that after the third nuisance, the City can file with Bedford Municipal Court.

Mr. Burns stated he has had a problem with a neighbor for two years that includes threats, vandalizing of his property and harassment. He stated that he has filed numerous police reports and a videotape of the trespassing of this individual. He commented that he was told that the way Bedford Court is structured he would have to have hardcore evidence in order to press charges.

**Chief Haynes** stated he would need to review the police reports with him after the Council meeting.

She reported that Warrensville Heights High School will be celebrating national *African American Read-in Day* which was established in 1990 and is the oldest program of its type. Councilwoman Mitchell shared she was invited to be at the event and it is nice to know that programs like this exists. She also encouraged early voting and stated if any of her ward residents or meeting attendees wants to do so she will take their ballots to the BOE.
